Scholarship program. During FY 2013, 41 scholarships were awarded to high school and college students to provide educational assistance to relatives of current and former submarine veterans. The foundation received 71 applications. Recipients in both the high school and college categories received awards ranging from \$ 950 to \$ 3,000. Total amount awarded in FY 2013 was \$ 52,050.

4b (Code:) (Expenses \$ 4,798 including grants of \$ 2,700) (Revenue \$ 15,324)

Memorial program. During FY2013 the Foundation spent \$ 2,700 to improve and maintain memorials at two locations in the U.S..

4c (Code:) (Expenses \$ 14,562 including grants of \$ 13,750) (Revenue \$ 4,761)

Brotherhood program. This program helps needy submarine veterans who become unable to work or function normally due to medical or natural disaster issues. It also provides support to needy families of U.S. Navy active duty sailors (E-5 and below). During FY 2013 this program also distributed \$ 6,000 to active duty sailors via the Submarine Force Command Master Chiefs.
