John Anderson: Motion to approve \$210.00 to build shelves for USSVI books at St Mary's museum. Seconded. Discussion: We have 800 books. Do they have room to store the books? Should we consider adding onto the museum? We should leave this to Library Committee to make recommendations.

Seconded. Approved unanimously.

NSVC notify NT to issue check to John Crouse of St Mary's Submarine Museum for \$210 to build the shelves for the USSVI books.

INFO: We have a contract with Cars for Causes in CA/NEV area to accept donated cars and sell them, splitting the profits with the CF. We take cars, stocks, property, etc, for resale to benefit the CF.

PHouseholder: I proposed we establish national fundraising program for CF with base awards weighted by number of members per base. This will also demonstrate to solicited foundations that we are making good faith efforts within USSVI to raise money as well. JPeters: It is a good concept.
